### **Approval of previous meeting's minutes:**

*Anthony* made the **MOTION** to accept the previous meeting's minutes; *Peirce* seconded the motion; **passed unanimously**

*Anthony* introduced everyone to Cheri Monnell for those that did not know her and *Monnell* introduced her guest, Donald Garland 51<sup>st</sup> CCDD Devel Dog. *Garland* shared a little bit about himself and that he was a former original member of the Granite State Detachment and retired from the Marines after 30 years and now lives in Virginia. He only visits NH a couple of times a year, and this time it coincides with a GSD meeting so he thought he would drop in. He was welcomed by the group.

*Anthony* shared that long-time members John and Ellen Petralito are dealing with Ellen's advanced stage Alzheimer's and that is why they have not been to meetings lately. *Anthony* made a motion to extend a life membership to Ellen Petralito, as John is already a life member, for all their efforts and participation in years past. The motion was seconded by *Peirce*. *Romano* stated that based on the age bracket that Ellen is in, the rate for a life membership for her is \$400. There being no additional discussion, a vote was taken and the motion passed unanimously. *Anthony* also asked *Romano* to do up a frameable certificate to be given to John and Ellen. She agreed to create one.

*Peirce* then explained a little about the Liberty House, being one of the only transitional halfway houses for veterans in NH, and they are having their annual Veterans Day Breakfast fundraiser on November 8<sup>th</sup> in Derry. See New Business below for details on the motion that was presented.

*Peirce* mentioned an idea that he had for the flagpole and solar light that was purchased 4-5 years ago that is currently sitting in storage. When he was recently at the Easterseals Campus in Franklin, NH he met with the Catholic priest in charge of the cemetery that is right behind the Easterseals campus. The priest was planning to do a fundraiser to obtain a flagpole for the cemetery. *Peirce* mentioned to him that he may know of a flagpole and not do anything until he got back to him. His idea is to have GSD 542 donate the flagpole and solar light to the cemetery and have it up and flying before Veterans Day. See New Business for the presented motion.

*Anthony* then shared what he would like to see for the Honors Detail within the detachment. He would like to see this section have more organization, training, and M1's, and find several people that would be interested in being on call for any firing honor details that are needed. He is going to ask Jim Ambrose, dual member of GSD and Seacoast detachments, to see if he would be willing to take on this task. *Garland* mentioned that the VA will compensate for Honor Details, and he suggested that Bob Borka from National be contacted for more information. *Peirce* then stated that the real problem is not getting the M1's, it is storing them. It was mentioned that Seacoast and Dillion detachments have rifles. *Peirce* then stated that the VFW in Franklin, that he is a member of and is a few miles from the Boscowan Cemetery, has 15 rifles and he thinks GSD could work out something with the VFW post to use these rifles when needed as they are not being used all that often at the present time. *Peirce* stated he will talk with them to see what can be done. *Anthony* took a call for hands of those interested in being part of this Honors Detail – Jesse Stufflebeam, Steve White, Kaylee Bass, and Eric Anthony. *Garland* mentioned that there is training on firing details for the proper form and process on the National website and stated the detachment should stay within the guidelines.

*Romano* then stated that she is on the Manchester Expeditionary Brigade luncheon planning committee. She shared that an email will be going out soon with registration information for the luncheon that will be held on November 10<sup>th</sup> at 11am to about 2:30pm and will be at the Derryfield Country Club and will be \$50 per person. She recommends if someone plans to attend, to sign up when the email comes out as they expect registration to fill up quickly this year as it is the 250<sup>th</sup> anniversary.

*Anthony* stated he had been in discussions with Jesse Stufflebeam about the open positions and if he would be interested in any. From the result of this conversation, *Anthony* appointed Jesse Stufflebeam as the new Senior Vice Commandant who will fill the remainder of the current term with elections in October and November for the term to start in June 2026. *Stufflebeam* graciously accepted the appointment and will start to get himself acquainted with the position. All at the meeting thanked him for accepting the position and wished him well.

## **Reports of Officers**

**Senior Vice Commandant: (position open at present) – NTR**

**Paymasters Report: (Marge Romano) – See attached report from Paymaster**

\$50,493.00 balance; \$200 in outstanding checks; committed funds \$1903 for the Dan Fedor Boy Scout Camp Campership 2025 designated for one to two canoes. She reported that the detachment raised \$1062 from the Bass Pro Shops Labor Day fundraiser. Membership renewal have been coming in and currently have \$175 received.

*Romano* was asked at the Executive Committee meeting from 9/6/25 for a couple of items and she shared this information with membership next. The preliminary dates to ask Market Basket and Bass Pro Shops for fundraising events in 2026 were discussed and she has a form letter that she will adapt to both stores and send them out to each once their window opens for acceptance of requests for 2026 in December of 2025. She will do up the draft letters and get approval from *Anthony* before sending.

Secondly, she was asked to get pricing for service flags from the vendor that the American flags are purchased from. The initial non-formal quote from Fully Promoted was \$5.60 each for a quantity of 50 for each of the 6 military branches; pricing may be lower if ordered in larger quantity. *Brown* stated it was not worth looking for other vendors as the pricing would be the same. *White* mentioned that from the inventory that he recently did, there are several branches of military flags, and he can get a count for what is in storage before a decision of purchasing any is made.

Lastly, *Romano* stated that she was contacted by the Revo Casino in Lebanon for GSD to come up for a photo op on September 23<sup>rd</sup> from 5:20-5:30pm. This will help keep GSD in the minds of Revo Casino in a positive light when they are selecting the non-profit organizations for 2026, and it reinforces the commitment the detachment has in this program and how the funds can benefit the mission of the MCL and the detachment. She asked if anyone was interested in attending this with her and *Anthony (Eric & Pat)* to let her know.

*Romano* stated that recently *Eric & Pat Anthony, Joe & Joey Duquette*, and herself went to the Chester Rod and Gun Club to have a check presentation from them to the detachment for the proceeds from the Dave Hamilton memorial shoot event. Pictures will be in the upcoming GSD newsletter.

#### **Judge Advocate: Chris Peirce**

*Peirce* reported that he recently attended SWIM with a Mission event that has over 60 veteran organizations at the summit. He shared copies a couple of documents

with various veteran resources that he obtained from attending. He also spoke to the coordinator for Wounded Warriors and was told there are a couple of events coming up that we could partner with them on, Fright Night in October, or a Christmas Caroling show, or we could come up with a different event. This is for networking purposes not fundraising.

**Junior Vice Commandant: (position open at present) – NTR**

**Quartermaster: (Steve White)**

*White* stated that he did an inventory of the storage unit this past Sunday with *Stufflebeam* and he will get the inventory typed up so it is clear what is there and what we may need to get. He will be checking all the chairs, easels, and stands to make sure they are functioning correctly. *Anthony* asked for a list of recommendations from *White* of what needs to be replaced or updated, such as the display screen that has the names of the organizations the detachment supports, as at least one of those does not exist any longer.

*White* mentioned that there are three wooden flags in the storage unit and that is just money sitting in storage. These are the display wooden flags for the fundraising events. At this time, *Romano* commented that at a recent prior meeting it was approved to donate a wooden flag to the Manchester Expeditionary Brigade that they could raffle off at the luncheon in November and to put a EGA or message on the bottom. *Peirce* recommended that we use one of the wooden flags from storage and purchase a brass plaque and inscribe a message on it for the 250<sup>th</sup> anniversary. All at the meeting thought this was a great idea.

When they meet, he mentioned that some things will need to be remembered: operational expenses, setting up a relief fund, keeping the donations to a 75/25 split between veterans and community and then stated there are plenty of worthy veteran organization in the Manchester area to select from for donations.

*Peirce* then mentioned that the Manchester Veterans Council has a fundraiser currently to raise funds for a statue in a local park. *Romano* said that she has a listing of all the organizations that the detachment has made donations to in the past and she will provide that to the committee at the meeting.
