## **Approval of previous meeting's minutes:**

*Peirce* made the **MOTION** to accept the previous meeting's minutes; *Brown* seconded the motion; **passed unanimously**

The meeting opened with a presentation from Courtney Stairs from Veterans Count a program of Easterseals. Veterans Count has four branches in NH, and they offer many services to all who have served in the military, regardless of service era, discharge status, or VA eligibility. They help veterans access the services and support that they need. They offer mental health counseling, care coordination, substance use treatment coordination, housing stabilization, benefits and services connection, aging and senior needs, money management, and emergency financial assistance. Their case managers go to the veteran where they are, and the veteran is not required to come into the Veterans Count office.

The Veterans Count services are free, but there may be some expense when the counselor passes the veteran over to another service, depending on the program. The only requirement is that the veteran lives or drills in NH. *Brian Hanson* from Worker Bees Fund who was also at the meeting, commented that Veterans Count is very discreet, and they understand how some veterans are disengaged and hard to get them out of their homes on any given day. *George Robinson* shared his experience when he transitioned from active duty to civilian life and he was told that the Navy and Marine Corps Relief Society would be the go to place for help with the transition, but it was coming to its end of service soon. Since the Relief Society is no longer active, Veterans Count is a good replacement and in many ways an improvement.

*Robinson* stated he went to a Veterans Count Gala a couple of years ago and he wondered if there was any other fundraisers or events that are put on by Veterans Count. *Stairs* said that each of the four branches in the state do a galla and have events all year long. She will send the 2026 calendar to *Anthony* and *Zurwell* so that it can be shared with the detachment.

*Anthony* then made a motion to donate \$1000 to Veterans Count in support of their mission. The motion was seconded by *Brown*. During discussion, *Peirce* stated that the Donation Evaluation committee is OK with this donation. With no further discussion, a vote was cast and the motion passed unanimously. There was a short break at this point to take a couple of pictures with *Anthony* presenting the check to *Courtney Stairs*.

At this point, *Cody Dumont*, Commandant of the Department of NH performed the installation ceremony for all the Granite State Detachment #542 elected officers and appointed officers. Below is a list of these officers:

*Brian Hanson* the founder of Worker Beas Fund then made a short presentation of why he started the Worker Beas Fund. From his years of volunteering at New Horizons he saw a need to help veterans who needed the services at New Horizons. He wanted to find a way to help veterans stay in their existing homes for a few more years with some alterations to the home so it would be possible. He is a building contractor and engineer by trade and thought he would use his skills to help veterans that need ramps, kitchen alterations to accommodate a scooter or wheelchair and other items that would improve their quality of life.

He partners with Veterans Count and other veteran organizations and gets donations of materials from local suppliers for all of the projects that they do. They do the work themselves so there is no labor costs. Since 2017 Worker Bees Fund have done 75 projects to help veterans.

Although *Hanson* stated that money is not a concern and he was only at the meeting to share information about who and what Worker Bees Fund is all about, *Peirce* stated that we had already approved a donation and the check was already written, so *Hanson* graciously accepted the donation of \$1000.

*Dumont* then shared that with his work with foster children, he finds swing set for sale online and fixes them up and sets them up for foster children at their foster parents' homes. He stated to *Hanson* that if any of the projects that he does involves children he would be happy to find and fix up swing sets for the homes and the children. *Hanson* said that was great and he would contact him if such a case came up. At that time, there was a small break to take a couple of pictures of *Anthony* and *Peirce* presenting the check to Brian Hanson of Worker Bees Fund.

At the November meeting, *Anthony* discussed the Manchester Veterans Council and their current fundraiser for the Gulf Wars Global War On Terror Memorial. He reached out to one of the Co-Chairmen of the project, Dick Anagnost, who is also a member of GSD 542, so that he could explain a little about the project, but he did not reply before the December meeting. From the flyer that *Anthony* shared at the meeting, the Manchester Veterans Council (MVC) is composed of volunteer representatives of all of the veteran organizations in Manchester. Their mission is to advise and assist the Mayor and Aldermen on veterans' affairs, organize and conduct the Memorial Day Parade, and Pearl Harbor Day Remembrance ceremony, as well as other activities related to veterans.

Any size donation is accepted, but they do have two sponsorship level donations, first is to sponsor a granite post with a 6 x 6 bronze plaque; for \$3000 the business can sponsor a granite post engraved with the company name, a message of support, or the names of veterans wished to honor. The second level is a sponsorship of a granite 12 x12 paver; for \$200 a business can sponsor a granite paver that will be incorporated into the walkway surrounding the monument.

*Anthony* made a motion to donate \$3000 to Manchester Veterans Council and their current fundraiser for the Gulf Wars Global War On Terror Memorial for a sponsorship level of the granite post with 6 x 6 bronze plaque. The motion was seconded by *Stuffelbeam* and with no further discussion the vote was passed unanimously.

*Anthony* then made a motion to present a Christmas gift card of \$250 to Susie, for all the great service she has provided GSD #542 in 2025 as the server at the monthly breakfasts at the Airport Diner. *White* seconded the motion, with no further discussion the vote passed unanimously.

*Anthony* then made a motion to increase Jo *Zurwell*'s monthly salary from \$200 to \$250 for all the great work that she has been doing with the website and the minutes etc. The motion was seconded by *White*, with no further discussion, a vote was taken and all were in favor with one abstention and the vote passed.

A short discussion was held about the upcoming December breakfast. The date of the breakfast has been changed from December 27<sup>th</sup> due to the holidays at the end of the month and will be held on January 3, 2026. *Anthony* stated that he has reached out to the Airport Diner to make sure they were OK with this change, so they had the proper staffing, and they had no issue. A question was asked if there will be a Yankee Swap like has been done in the past. After a short discussion there was no one that was willing or able to do the organizing of this event this year, so it was decided that there will not be a Yankee Swap this year. *Romano* mentioned that she has heard from a few people, including Susie, that people have not been tipping at the breakfast and someone will need to remind people to do so at each breakfast as a courtesy for the hard work that is done.

*Anthony* then explained about Marine Jim Mesita who is a local veteran in Nashua who has been having a hard time lately with his mortgage and HOA fees. Brad *Howe* from the Seacoast Detachment has been in touch with Jim and Veterans Count to vet his situation out. There are a lot of moving parts with lawyers and the HOA and Veterans Count has been helping Jim with reducing his mortgage and HOA fees so that he does not get upside down again with his financial situation.

*Howe* has reached out to the Department of NH MCL as well as Granite State Detachment to help support this Marine in need at this time. *Anthony* made a motion to contribute \$1533, a third of the total needed, \$4600, to Marine Jim Mesita. The motion was seconded by *Coutu* and a discussion was held. *Peirce* voiced his concern that when helping an individual like this that all due diligence is done to vet the situation and make sure that this person is not a repeat offender or someone that is trying to scam generous organizations out of their money. He said that it sounds like the vetting process that Brad Howe has done is the right way to handle things.

*Dumont* then added that he met with the Seacoast Detachment last night and discussed this with Dick Lak the Commandant there, he is a former lawyer, and Lak stated that no one will be receiving any funds until he is happy with what is presented as evidence of need and that this is not a repeat offender of this type of request. *Dumont* then stated that the check should be made out to and mailed to the Seacoast Detachment PO box. Once the funds are deemed fit to distribute they will send a full check to Jim Mesita. If it is found that he is not fit to receive the funds, the Seacoast Detachment will return the \$1533 back to GSD 542. With no further discussion a vote was cast and the motion passed unanimously.

## **Reports of Officers**

### **Senior Vice Commandant: (Jesse Stufflebeam) –**

*Stufflebeam* stated that he had talked with the contact at Bass Pro Shops about the February fundraiser and what he need to do to request the dates desired. He has this information now and will be doing as required. He will report back when the dates are confirmed. He also mailed the letters to Market Basket to request the fundraising dates wanted in 2026 by the detachment. Once he hears confirmation back from them he will advise.

### **Paymasters Report: (Marge Romano) – See attached report from Paymaster**

\$46,003.47 balance; \$3,100 outstanding checks; committed funds \$1,903 for the Dan Fedor Boy Scout Camp Campership 2025 designated for one to two canoes, \$1,500 for Maurice Labbe memorial paver, \$500 Arts for Veterans, \$1,000 Delta Dog, \$1,000 Harbor Care, and \$1,000 Hometown Heros Outdoors; total committed \$6,900. Total available funds is \$36,000.47.

Other news from the paymaster, *Romano* presented the check of \$1,000 to the Blue Star Mothers this past Saturday December 6<sup>th</sup>. GSD 542 has been accepted by Revo Casino for 2026 at the Lebanon casino. She will be doing the application and other paperwork that Senaca from Revo Casino will be sending her by the deadline of December 15, 2025.

*Romano* then brought up a concern regarding the Maurice Labbe memorial paver stone at Easterseals NH in Franklin. There was a recent article in NHPR, see the link hear [NH's new veterans campus contends with a wave of resignations, resident](#)

[complaints | New Hampshire Public Radio](#) that explains the situation currently unfolding at the Easterseals NH campus in Franklin. The CEO and three other top administrators of the campus have resigned their positions recently due to lack of proper management by Easterseals for the campus to perform its mission. Please read the article for full details.

*Romano* made a motion to put a hold on the check designated for the Maurice Labbe memorial paver on the Easterseals campus, until Easterseals has the ability to work out their internal issues. This motion was seconded by *Stuffelbeam*. Discussion was had and *Dumont* offered a different perspective, the campus is just getting off the ground and there are bound to be problems along the way, some of the veterans may not realize what is free for them to use and what is not at this point, and Easterseals is working to get everything working correctly. There are going to be growing pains, and he suggests that time and space is given to allow them a chance to deal with these starting off issues of concern. With no further discussion, a vote was cast, and it passed unanimously to put a pause on the release of the funds to Easterseals NH.
